The Whistle Stop Gallery needs YOU! We're hosting an amazing show in August 2018 called "Sketches: Year One" at the State Street Station. We're looking for family-friendly sketches that are 9x12 inches or smaller. We're looking for new work that highlights the creative process.

All work must be for sale, and will be offered for \$15 with \$10 of that being paid to the artist. There's no fee to submit your work or display. Works will remain with the Whistle Stop Gallery until sold - they may be exhibited online or in our other shows as well. Each artist should submit one work so we can have maximum variety.

Interesting surfaces are also encouraged, such as a clean napkin, a magazine page, etc. Submissions that are found inappropriate or not in good condition can be returned at the artist's expense, but plan on submitting something we can use because we want to sell your work! Works may rotate in and out during the exhibit, depending on how many we get.

The exhibit focuses on drawing media – please don't submit photography, painting, digital art, sculpture, or anything else that isn't drawing media. Artists must be adults (age of majority) and agree to our rules, instructions, and terms. Submissions will be accepted until the end of the show. You will need to complete and return the Agreement in order to participate. You can also stop by during the show and use our Sketch Desk!

Delivery of the artwork is my responsibility and at my expense. My options are

1. Ship artwork to Whistle Stop Gallery, P.O. Box 967, Granite City, IL, 62040 (USA)
2. hand deliver the artwork to Joseph A. Langley at the show location during open hours

Return of unsuitable work is my responsibility and at my expense. My options are:

1. Make a mutually agreed upon appointment to pick up the work in person at the show location
2. Joseph A. Langley will prepare a return shipping estimate via USPS and bill me, and will ship the artwork back after I pay

The Whistle Stop Gallery (the Gallery) will make reasonable effort to treat artworks with care and keep them secure while they are in the Gallery's custody. The Gallery will inspect artwork for condition and readiness to display and act accordingly. Artwork that is not acceptable for display will be returned at my expense.

I will allow my work to be offered for sale with a price of \$15. I will receive \$10 of the Retail Price if my artwork is sold, and the Gallery will retain \$5. The Gallery will collect and remit Sales Tax appropriately as per its Illinois Department of Revenue registration. My work will be kept until sold.

I will complete the Artwork Inventory.

The artwork I have listed in this Agreement is my own creation, is 9x12 inches or smaller, and was created using drawing media. I will provide reasonable additional information to the Gallery upon request by email or mail.
